In 2025 the Ranch hosted 249 volunteers with 6,250 volunteer hours. There were 73 Thrift store volunteers who contributed 3,797 hours to the operation. 247 people attended programs at the Ranch and we hosted many organizations including Keystone Science School, Building Hope, BGV, 4-H and SOS Outreach. Through our new Horses Helping Humans program we've expanded into support for people with special needs and first responders.
